Coronavirus Update

Thursday 2 September 2021

Dear colleagues,

The Victorian Government has announced some minor changes to lockdown restrictions from 11:59pm Thursday 2 September – reopening of playgrounds with QR codes in place and allowing in-home childcare arrangements – but perhaps not the good news we had hoped for.

There is some hope though. An initial roadmap out of lockdown was announced yesterday, based on increased vaccination rates, as well as some better news for regional Victoria.

- **Regional Victoria** lockdown may be eased in regional Victoria next week, with significant restrictions still in place. An announcement is expected early next week but until then lockdown continues.
- Melbourne metropolitan areas Victoria is expected to reach 70+ per cent vaccination by 23 September, then restrictions for metropolitan Melbourne will begin to be eased. Until then, lockdown continues in metropolitan Melbourne for a further three weeks.

The reasons highlighted by government for these decisions are due to the highly infectious nature of the Delta strain of COVID-19 and the need to balance suppressing case numbers and hospitalisations and increasing vaccinations.

Impact on Federation University and TAFE operations

There is no change to the advice provided previously regarding on-campus activities and operations.

- In accordance with lockdown restrictions, our campuses in Ballarat, Berwick, Gippsland and the Wimmera will be closed until Thursday 23 September (pending further government announcements).
- Brisbane Campus remains open and is unaffected by the Victorian restrictions.
- In Victoria, some practical activities for TAFE and higher education will continue on campus, in line with government restrictions, with a permit in place (details below). Staff and students will be contacted directly by their supervisor if applicable to them.

Key advice to Federation staff

Find information on COVID-19 vaccinations

Federation University recognises that vaccination is a crucial part of the public health response to the COVID-19 pandemic – and this is reflected in the roadmap out of lockdown announced by government.

We strongly encourage our staff and students to get the COVID-19 vaccination as the best way to protect themselves, their loved ones and their communities from the virus.

Everyone aged 16 and over are now eligible to receive a COVID-19 vaccine.

Working from home

- All staff and students without an authorised work or higher education permit issued by the University must work from home. Please do not attend campus.
- For continuing and fixed term staff If your job cannot be performed from home, there is no need to take special leave. Please consider if there are any administrative or professional development tasks that you can catch up on during this time.
- For casual and sessional staff Managers and supervisors need to discuss
 options with casual and sessional employees to identify any duties that can be
 performed from home during the lockdown period. Managers and supervisors can
 seek further advice from their HR Business Partner. We understand that this is a
 difficult time for many in casual work and this has been recognised by
 government, with a number of options to seek income support. You can find

Seeking an authorised work or higher education permit

- Permit applications staff all eligible staff should contact Human Resources to obtain an authorised work permit via <u>hr.hotline@federation.edu.au</u> or call 03 5327 6300.
- Permit applications higher education students email <u>WIL@federation.edu.au</u>
- Permit applications HDR students email <u>dean.gradstudies@federation.edu.au</u>
- Permit applications TAFE students you must have a permit to attend oncampus studies.
- Authorised apprentices will need to seek a permit from their employer to continue study on campus.
- The only non-apprentice group of students allowed onsite for practical delivery is Diploma of Nursing. Email Lee Wheeler, Education Manager Health and Nursing Programs at l.wheeler@federation.edu.au.
- All other TAFE work placements must be reviewed by the General Manager, TAFE email <u>tafe.placements@federation.edu.au</u>.

All childcare centres and kinders across Victoria are closed, except to children that have one parent that is an authorised worker. Vulnerable children can still attend. An authorised work permit is required to access childcare.
