### Student Financial Assistance - Student Loan

#### Introduction

The purpose of Federation University Australia Student Financial Assistance Fund is to provide financial support to eligible students who are experiencing financial hardship which is adversely affecting their education. The main criteria for student loans are the demonstration of a genuine need and the capacity for continued study may be in jeopardy due to financial hardship.

A student loan will not be provided for the payment of the following University costs:

- Commonwealth supported place (CSP) charges
- TAFE or Higher Education tuition fees, material fees or ancillary fees
- Student Services and Amenities Fee (SSAF)
- student visa charges (for International students)
- holiday expenses (recreational travel)
- any debt incurred before enrolling at the University
- · credit card or loan debts
- purchasing vehicles
- fines and penalties
- · costs associated with moving into on-campus student residences

### **Eligibility criteria**

The Student Financial Support Officer will review the student's eligibility as per the Student Financial Assistance Policy and Procedure. Any student applying for \$0 - \$2,000 loan must:

- be currently enrolled in an award program at FedUni;
- be over 18 years;
- be able to demonstrate that you are experiencing financial difficulties;
- demonstrate an ability to make regular repayments;
- · have no outstanding student loans;

If students are applying for a \$1,001 - \$2,000 loan they must also:

- have successfully completed at least one semester of study at Federation University Australia; and
- provide details of a guarantor.
