Purpose

• The purpose of this Contract Notification is to advise the Training Provider of variations to the 2019 Funded Courses Report.

Background

• VET Funding Contacts provide the Department with power to vary the Funded Courses Report.

Main Points

• The 2019 Funded Courses Report will be varied as described below.

Variations to the 'Maximum Payable Hours'

- The Maximum Scheduled Hours (Maximum Payable Hours/Maximum Nominal Hours) published for each qualification in the Funded Courses Report are intended to be consistent with those published in the relevant Purchasing Guide.
- In three instances, the Maximum Payable Hours as published in the 2019 Funded Courses Report are <u>less</u> <u>than</u> those published in the relevant Purchasing Guide. For these three instances, the Maximum Payable Hours are hereby amended (increased) as detailed in Part 1 of Attachment 1. So as not to disadvantage the Training Provider and current students, these changes will be applied to all active enrolments.
- In three instances, the Maximum Payable Hours as published in the 2019 Funded Courses Report are <u>greater</u> than those published in the relevant Purchasing Guide. For these three instances, the Maximum Payable Hours are hereby amended (decreased) as detailed in Part 2 of Attachment 1, effective for all enrolments with a Course Commencement Date from 1 July 2019.
- With respect to the three instances where the Maximum Payable Hours will be reduced, so as not to
 disadvantage any student who, in good faith, was enrolled in and commenced one of these qualifications prior
 to 1 July 2019, the Department will honour the Maximum Nominal Hours as originally published for these
 current students. This may require an "offline" payment to the Training Provider where payments are otherwise
 blocked by SVTS.
- The Department will undertake an annual reconciliation following the close of each collection year, to cover any affected students who have completed training in that year, and will work with Training Providers as necessary to ensure appropriate payments are received.
