

# TERTIARY EDUCATION SETTINGS CORONAVIRUS (COVID-19) – FREQUENTLY ASKED QUESTIONS

27 OCTOBER 2021 – VERSION 24

This fact sheet is for all tertiary education providers, including Learn Locals, TAFEs, registered training organisations and universities. **This includes organisations located in both metropolitan Melbourne and regional Victoria.**

The information in this document is current as of the date of publication.

Tertiary education providers should familiarise themselves with [Victoria's Roadmap](#), and continue to monitor information as it becomes available via the Department of Health (DH) website. Please refer to the latest information to ensure the most accurate advice.

## Can staff members and students attend training providers' premises?

In line with advice from the Victorian Chief Health Officer, as at 11:59pm Thursday 21 October 2021 all TAFEs, universities, Learn Locals and other training providers in Victoria may operate for the purposes of supporting students with hands-on, skills-based learning, or facilitating exams and assessments when it is not practicable to conduct them remotely.

Permits are no longer required for on-site attendance for the above-mentioned reasons.

For the time being, all other staff and students must continue to work and learn from home.

To the extent possible, TAFEs, universities and other training providers should continue to ensure that students have access to digital and remote learning classrooms and materials to enable learning from home.

## Movement between metropolitan Melbourne and regional Victoria:

Students and staff who reside in a metropolitan Melbourne and are enrolled or work in a TAFE, university or training institution in regional Victoria can only attend onsite if their study is listed on the [authorised provider and authorised worker list](#).

Permits are no longer required for movement between metropolitan Melbourne and regional Victoria. However, affected students and staff must travel directly to the training organisation and limit movement as much as possible while in regional Victoria. When in regional Victoria, the restrictions from metropolitan Melbourne will travel with the worker.

## Movement between regional Victoria and metropolitan Melbourne:

Residents of regional Victoria can only travel to metropolitan Melbourne for limited reasons as noted in the [Stay Safe Directions \(regional Victoria\)](#) and must abide by all restrictions detailed in the [COVIDSafe Settings](#).

Note that from 6pm Friday 29 October 2021, movement between regional Victoria and metropolitan Melbourne (in either direction) will be free of restrictions.

## Who is required to have a COVID-19 vaccination?

The Victorian Chief Health Officer (CHO) has determined that all workers defined as higher education workers in the [CHO Directions](#), in both metropolitan Melbourne and regional Victoria, will be required to be vaccinated against COVID-19. This includes workers in higher education, TAFE, and training and adult education.

To continue working on-site, currently these workers must provide evidence that:

- they had a first dose COVID-19 vaccine by 15 October 2021, or
- they have a booking to receive a first dose by 22 October 2021, or
- have a medical exception evidenced by an authorised medical practitioner.

From 26 November 2021, to work on-site, workers must be able to provide evidence to their employer that they have received a second dose and are fully vaccinated, unless a medical exception applies.

The vaccination requirements also apply to:

- apprentices, trainees or volunteers working on-site in accordance with the CHO Directions
- apprentices and trainees in employment and students in specific settings (work placements and at residential aged care facilities, healthcare facilities, construction sites and education facilities)
- school students undertaking placement in aged care, education, health care and construction sectors.

The 15 October 2021 deadline does not apply to workers who already have existing requirements under Chief Health Officer directions – groups like construction, freight, healthcare, aged care and education will still have to comply with previous advice.

The current [COVID-19 Mandatory Vaccination \(Workers\) Directions](#) do not apply to students, apprentices and trainees currently undertaking permitted onsite learning (unless they are in the specific settings outlined above). **However, once the state reaches 80 per cent fully vaccinated, all students are required to be fully vaccinated to attend onsite learning.**

### **How can someone show evidence of vaccination?**

Evidence of a person's vaccination can include:

- their [COVID-19 digital certificate](#) which shows proof of only their COVID-19 vaccinations that they can add to a digital wallet
- their [immunisation history statement](#) which lists their COVID-19 vaccinations and all other vaccinations
- a letter from a General Practitioner.

There are no requirements to retain a copy of this evidence, however organisations must take all reasonable steps to assure themselves of the vaccination status of anyone attending on-site where required.

### **Do secondary school students need to be vaccinated to participate in VCE/VCAL courses, or other subjects related to the completion of their secondary education, if attending at a higher education premises?**

No, currently school students participating in VCE/VCAL or other courses including VET related to the completion of their secondary education at a higher education premises are not required to be vaccinated to participate in face-to-face learning or exams.

### **Are students completing VCE/VCAL at a non-school senior secondary provider (NSSSP) required to be vaccinated to participate in on site learning?**

No, currently students completing VCE/VCAL or other courses including VET related to the completion of their secondary education at a NSSSP are not required to be vaccinated to participate in face-to-face learning or exams, including when undertaking a VET subject with a higher education provider.

### **Are students who are Primary Close Contacts (PCC) permitted to sit senior secondary exams?**

A student who is a PCC can sit exams (any exam relating to their senior secondary certificate) and does not need to have been vaccinated in order to do so. This is permitted under the [Diagnosed Persons and Close Contacts Directions \(No 31\)](#). Only a student who is diagnosed with COVID is unable to sit an exam.

### **What are the clinical placement requirements?**

Training and assessment for health, aged, and disability care workers, including clinical placements, is permitted for students appropriately vaccinated.

### **Are face masks required for training and/or assessment?**

Regardless of location, face masks must be worn indoors and outdoors whenever you leave your home unless an exception applies. This includes when conducting training and/or assessment.

Note that from 6pm Friday 29 October 2021, masks will not be mandated outdoors.

### **What are the arrangements for students and staff in Victorian border communities?**

#### **Victorian Residents:**

Students and staff who live in Victorian border communities and are enrolled in or work in a TAFE, university or training provider in a bordering state will be able to attend on site if permitted by that State, and in accordance with any relevant travel permits.

#### **NSW Residents:**

Students from cross-border communities who reside in NSW but attend a Victorian TAFE, training organisation or university can study on-site if they abide by the conditions of the [Border Crossing Permit Directions](#). This currently includes obtaining a [border entry permit](#).

#### **SA Residents:**

If you live in a South Australian LGA within the cross-border area, you do not need to

apply for a permit to enter Victoria, provided:

- you are not a diagnosed person or a close contact of a diagnosed person
- you are not experiencing COVID-19 symptoms
- you have not been in an extreme risk zone or red zone outside of the cross-border area at any time after the relevant zone commencement time in the previous 14 days

To travel into Victoria without a permit, people who live in the cross-border community need to carry proof of address (such as a driver's licence).
