

STATUTE 3.4-DEPUTY VICE-CHANCELLOR

Council to appoint Deputy Vice-Chancellor

1. The Council may appoint one or more persons to be Deputy Vice-Chancellors.

Term of office

2. (1) A Deputy Vice-Chancellor holds office unless he or she resigns, retires or otherwise ceases to hold office, for such term, on such conditions and with such title as the Council determines and may be re-appointed.
- (2) The Council may from time to time change the title of a Deputy Vice-Chancellor.

Powers and duties

3. (1) A Deputy Vice-Chancellor shall exercise and perform such powers, authorities, functions and duties as are conferred or imposed on or delegated to him or her by or under-
 - (a) the Act, the Statutes and the Regulations;
 - (b) a resolution of the Council; and
 - (c) subject to sub-paragraphs (a) and (b), a direction of the Vice-Chancellor.
- (2) Subject to the Act, the Statutes or the Regulations and to any relevant resolutions of the Council or direction of the Vice-Chancellor, a Deputy Vice-Chancellor shall-
 - (a) be entitled to attend and speak (but not vote) at meetings of all committees, boards and other bodies constituted by or under the Statutes and Regulations;
 - (b) be entitled to consult with any member of staff; and
 - (c) be entitled to require any member of staff or any committee, board or other body constituted by or under the Statutes and Regulations to provide information which he or she considers relevant to the performance of his or her functions and duties or the exercise of his or her powers and authorities.
- (3) A Deputy Vice-Chancellor must report to the Vice-Chancellor on his or her activities at such time and in such manner as the Vice-Chancellor directs.

Delegation

4. Subject to any relevant resolution of the Council or direction of the Vice-Chancellor, a Deputy Vice-Chancellor may delegate all or any of the powers, authorities, duties and functions of his or her office, other than the powers, authorities, functions or duties delegated by the Council or the Vice-Chancellor to the Deputy Vice-Chancellor which are expressly stated not to be further delegated and this power of delegation, to any member of staff of the University or to any board, committee or other body constituted by or under the Statutes and Regulations.

Provision of Statute 3.3-The Vice-Chancellor applying to a Deputy Vice-Chancellor

5. The provisions of sections 4, 5, 6, 7, 8, 9 and 10 of Statute 3 3-The Vice-Chancellor shall apply to a Deputy Vice-Chancellor, the necessary changes being made.
