

## Skills First Foundation Skills Approved Provider List Step 2 - Pre-application self-assessment and planning

This document has been prepared to assist Training Providers:

- **not** currently on the Approved Provider List and considering an application to be an Approved Provider of government subsidised foundation skills training under *Skills First* from 2022; or
- wishing to add an extra domain—specifically under a VET Funding contract.

Training Providers considering making an application are strongly advised to use this document:

- to self-assess their likelihood of success and make an informed decision to apply **before** working on their application and paying the fee; and
- to learn what is required in the application and begin to prepare for making an application.

This document is closely based on the application and gives information on the documentation required in a completed application.

Applications must be lodged before 2 pm on 22 October 2021.

**This document is not evidence and must not be included in your application.**

### 1 – Unpack your foundation skills assessment and delivery process and consider your ability to provide evidence of high quality practice

## 2 – Evaluate your responses

If you have answered **Yes** to all of the previous statements, meaning you are able to provide comprehensive, self-explanatory evidence electronically, you are ready to make an application to become a Training Provider approved to deliver government subsidised foundation skills training under *Skills First*.

If you have answered Yes to the previous statements marked \*, but not to all the other statements, you will need to work on your documentation before you are ready to make an application to become a Training Provider approved to deliver government subsidised foundation skills training under *Skills First*. There are four comprehensive documents to be uploaded as you complete the application.

If you have not answered Yes to all the previous statements marked \*your Training Provider does not currently have, or cannot evidence, the high quality practices necessary to be approved to deliver government subsidised foundation skills training under *Skills First* and you should reconsider making an application.

## 3 – Other things to consider

In deciding whether to make an application to become a Training Provider approved to deliver government subsidised foundation skills training under *Skills First* you should also consider:

- that applications open on 23 September 2021 and the final date for applications to be received is 2 pm on 22 October 2021, plus your organisation's capacity to prepare an application in that time frame;
- that all documents must be provided at the time of application as there is no facility for late additions;
- that all evidence provided must clearly represent work done at your Training Provider;
- the requirement that your application focus on the course(s) in one or two specified domains for which the highest volume foundation skills is anticipated to be delivered in 2022. The course(s) must be current and on your Training Provider's Funded Scope when the application process opens; and
- that all documents must be saved as a PDF for upload. Files can be up to 8 MB each.
