Pathway/alternate entry

Students who have successfully completed a fourth year of university study in a nursing specialty area may be eligible for 120 credit points upon entry.

Entry requirements and exit points

- Undergraduate degree or graduate diploma in any health discipline or equivalent
- Other university qualification and appropriate industry experience

Exit points include:

- Graduate Diploma of Health (Advanced Nursing) – following successful completion of 120 credit points of study
- Graduate Certificate of Health (Advanced Nursing) – following successful completion of 60 credit points of study
