### Purpose

- This Contract Notification:
  - updates all versions of the 2018-19 VET Funding Contracts (the Contracts) to reflect variations already made throughout 2018 and to make additional minor variations for clarity;
  - $\circ$  advises training providers that version 2.0 of each Contract replaces version 1.0, and
  - advises that 2019 versions of the three key Guidelines supporting the Contract (the 2019 Guidelines About Apprenticeship and Traineeship Delivery, the 2019 Guidelines About Fees and the 2019 Guidelines About Determining Student Eligibility and Supporting Evidence) have been published in SVTS.

#### Background

- To assist training providers, and in response to feedback that it would be beneficial to receive detailed information to keep track of Contract changes, the Department of Education and Training (the Department) has prepared 'curated' versions of the Contracts that:
  - o incorporate all variations made to date in 2018 via Contract Notifications;
  - incorporate (where applicable) variations made in 2018 to implement new Government initiatives at TAFEs and Dual Sector universities (the Free TAFE for Priority Courses Initiative and the NDIS TAFE Training Campaign); and
  - include a number of additional variations to make clarifications and minor improvements. These
    variations do not make significant alterations to any of the core terms and conditions of the
    Contracts or to any policy settings of the Skills First program.
- The Department has also reviewed the three key Guidelines that support the Contracts and has made a small number of changes to align with the curated Contracts or to otherwise provide required updates. The 2019 Guidelines are published in advance, to give training providers the opportunity to make any required adjustments to business processes. As with the Contracts, the variations made do not represent any significant changes to current settings.
