

# Notice of Senate Applications and Elections

Applications: 12am Monday 4th March to 11:59pm Sunday 17th March 2024 Elections: 12.00am Thursday 21st March to 11.59pm Monday 25th March 2024 (if required)

Vacancies exist for 18 positions for students on Federation University's Student Senate. All Senate positions are for a two-year term, ending 8 April 2026.

The students successfully elected to these positions will be expected to attend up to eight meetings per year by videoconferencing, should anticipate around an hour of duties per week on average, and to attend several days of training across the year.

In addition to the eligibility criteria given against each role below, at time of applying all students must:

- i. Studying at a time fraction of 0.5 or more;
- ii. Not employed by the University at a time fraction of 0.5 or more;
- iii. 18 years or over (not applicable to Federation College and VCAL students); and
- iv. Not currently serving a custodial sentence,

The election is governed by the Federation University Australia (Operations) Regulations, Part 5, Divisions 1, 3, 4, 5, 6, 7, 8 and 9.

BALLARAT AND SURROUNDS AREA STUDENT REPRESENTATIVE (2 positions):	Acts to advocate on behalf of all students at the North Western Victoria campuses (Ballarat and Surrounds).	OPEN to Higher Education students enrolled at a course at the University's campuses in the North Western, Victoria area.
BERWICK AREA STUDENT REPRESENTATIVE (1 position):	Acts to advocate on behalf of all students at the Berwick campus.	OPEN to Higher Education students enrolled at a course at the University's Berwick Campus.
DISTANCE EDUCATION/OFF CAMPUS STUDENT REPRESENTATIVE (1 position):	Acts to advocate on behalf of all students studying off campus or via distance education.	OPEN to students enrolled in Distance Education/ Off-Campus courses of the University, who are required to pay the Student Services & Amenities Fee.

#### Written or Video Policy Statement

Each form must be submitted with a policy statement and photograph for use on FedUni Student Senate web pages, campus noticeboards and Senate social media. Policy statements must not exceed 300 words and photographs should be in JPEG format.

Alternatively, students may submit a pre-recorded video statement, which will be posted to the FedUni Student Senate web pages, campus noticeboards and Senate social media. The video should not exceed three minutes in length. MP4 or AVI format are preferred. Those submitting videos must still provide a separate photo and a transcript of the statement for accessibility.

### **Voting Arrangements**

If there is more than one application for any given position, an election will be held **12.00am Thursday 21st March to 11.59pm Monday 25th March 2024**. An online voting form will be made available at www.federation.edu.au/student-senate and emailed to all enrolled students.

The election uses a first-past-the-post voting system where each voter has a single vote and the candidate with the most votes wins. All enrolled students at Federation University are eligible to vote. For some positions, there are additional voting restrictions. For example:

- Campus-specific roles are elected by students who principally study at that campus.
- Distance/online representative to be elected by distance/online students.
- TAFE roles are to be elected by TAFE students.
- Higher Education roles are to be elected by Higher Education students.
- Institute specific roles are to be elected by the students of that institute.

At the close of the election, results will be announced to the candidates who will have 48hrs to lodge a dispute should they have any concerns. Disputes will be resolved by the Executive Officer in conjunction with the Dean of Students and the complainant. Complainants will receive timely communication and be informed of the outcome of their dispute.

Election results will be announced University-wide within 10 working days of the Election closing or upon resolution of outstanding disputes.
