

Promotion Terms & Conditions – GAME OF CHANCE

Information on prizes and how to enter form part of these Terms and Conditions of Entry ("the Conditions").

By entering this Promotion, all Entrants will be deemed to have accepted and agreed to be bound by these terms and conditions.

The Terms and Conditions of this Promotion are governed by the laws of the State of Victoria.

Entry to the Promotion is open to all current Federation University students at the time of entry into the Promotion.
