Purpose

This Contract Notification is to advise training providers of the SVTS payment processing dates for 2024 and January 2025.

Background

SVTS calculates your monthly Skills First payment based on the training delivery data you upload. We run the claims confirmation report each night to identify the payment records payable for the month. This process changes the status of these records to 'PAY' and adds them to the next payment processing cycle.

Main points

Submit correct data

Your data submission must be correct at the time of your upload. You must ensure that any incorrect claims are not processed for payment. For example, if you upload your data in error and generate a claim that would ordinarily be paid.

We start processing invoices on the third business day of each month. This means you have until the second business day of each month to 'unconfirm' any positive claims with the payment status of 'PAY' for which you do not want to be paid.

Data to meet the Student Statistical Collection Guidelines

You must submit training delivery data that complies with the Victorian VET Student Statistical Collection Guidelines. If your previously submitted data is incorrect, you must resubmit the correct data by the following month's payment processing date.
