Purpose

This contract notification is to advise training providers that from Tuesday 18 June 2024 you will need a new user account for SVTS as we migrate the hosting of the SVTS application to the Department of Jobs, Skills, Industry and Regions (DJSIR).

Background

On 1 January 2023, the skills and training portfolio moved from the Department of Education to DJSIR. As part of this move, we now are now transferring the application hosting of SVTS to DJSIR.

Main points

We will send you an email with instructions

We'll email you with all the instructions you need to log in to the new SVTS address. Check the email isn't in your junk email folder.

If you're an organisation administrator, we will email you on Wednesday 12 June 2024. We'll email all other users on Monday 17 June 2024.

You'll need to register for a VicGov CIAM account and reset your password via a secure onetime passcode.

SVTS will be offline

SVTS will be unavailable from **12pm on Friday 14 June 2024** until **9am on Tuesday 18 June 2024** so we can complete the website migration.

We will not be processing claims for payment while SVTS is offline. The first claim processing run will be on the night of Tuesday 18 June 2024.

We'll only transfer active SVTS users

We will deactivate the accounts for any SVTS user who has not logged-in to SVTS since 1 January 2024. After the migration, your organisation administrator will be able to add, modify and remove SVTS user accounts for your training provider.

SVTS users since 22 May 2024

We will email any SVTS user who has signed-up to SVTS since 22 May 2024 in the week following the migration. They need to follow a different activation process.
