


Why do we care about academic integrity?



Academic Integrity practice is shaped by several drivers

At the University level, there are legislative requirements that we maintain policies and procedures for detection, prevention, and guidance on academic integrity





Examples of Academic Misconduct

Big, obvious examples:

- Impersonation for an exam or presentation
- Sneaking notes/devices into exam venues
- Buying a completed assignment
- Faking a medical certificate
- Less obvious, surprisingly common examples:
- Working together on an individual task
- Resubmitting previously-assessed work
- Sharing completed assignments with friends, or on CourseHero or similar




RPA Impact on Dairy Industry

BPMN Process Model (after disruption):



What to do??

This is the big question academics are grappling with at the moment

Two main perspectives:

- Using ChatGPT is **cheating**. The student is not submitting their own work
- ChatGPT is a **language calculator**. Take lessons from Mathematics.



ChatGPT is cheating

But, it's largely undetectable

OpenAI has recently added a detector, but as the *whole goal* of large language models is to be human-like, they can't detect their own AI model with much precision

Covered by Federation policies as *contract cheating*



This is the text generated for the previous question

The detector says *possibly* Al-generated Text


Students reviewing and critiquing the work of ChatGPT

Integrated with programming tool Visual Studio Code, and automatically writes code

Synthesia

Generates "talking head" videos

ElevenLabs

Upload a few minutes of somebody's voice, and convincingly synthesize it
