- 10. Other responsibilities applicable to a Level B academic under current minimum standards for Academic Levels, as assigned by the Executive Dean, Deputy Dean and Head of Speech Pathology.
- 11. Reflect and embed the University's strategic purpose, priorities and goals when exercising the responsibilities of this position.
- 12. Undertaking the responsibilities of the position adhering to:

### Level of supervision and responsibility

The Lecturer, Speech Pathology and Clinical Coordinator will work independently in the conduct of teaching and research activities, and be an active contributor to administrative functions within the institute.

#### Position and organisational relationships

The Lecturer, Speech Pathology and Clinical Coordinator will work under the broad direction of the Executive Dean, Deputy Dean and Head of Speech Pathology, and work as part of the institute's team of academic and administrative staff.

### Key selection criteria

Applicants must demonstrate they are able to undertake the inherent responsibilities of the position as contained in the position description and are able to meet the following key selection criteria:

#### **Training and qualifications**

- 1. The Lecturer, Speech Pathology and Clinical Coordinator will hold a higher degree in Speech Pathology and be enrolled or willing to enrol in a further higher degree qualification if they do not hold a PhD.
- 2. A Certified Practicing Member of Speech Pathology Australia.
- 3. All academic positions delivering education and/or services to children (a child for this purpose is considered to be someone below the age of 18 years) in first-year undergraduate courses must hold a valid Working with Children Check (WWCC) or hold a current registration with the Victorian Institute of Teaching (VIT).

#### Experience, knowledge and attributes

- 4. Commitment to scholarship and a potential for academic advancement.
- 5. Demonstrated commitment to and enthusiasm for teaching, and a good teaching record.
- 6. Previous experience in academic administration, including the administration of units and clinical coordination.
- 7. Evidence of research expertise and a demonstrated capacity and preparedness to achieve an active research profile in the field of speech pathology.
- 8. Evidence of an ability to work collegially.
- 9. Demonstrated interpersonal, oral and written communications skills and an ability to relate well to students and other University staff.
- 10. A capacity to contribute to the supervision of honours and graduate students.
- 11. Demonstrated ability to develop and implement a student-centred approach with a focus on student educational experience and success.
- 12. Knowledge and understanding of the needs, including learning needs, of a diverse range of students, including those with disabilities.
- 13. Demonstrated working knowledge and application of the Child Safety Standards.
- 14. Demonstrated knowledge and application of appropriate behaviours when engaging with children, including children with a disability and from culturally and/or linguistically diverse backgrounds.

# **Key Minimum Standards for Academic Levels (MSALs) Teaching and research academic staff**

#### Level B

A Level B academic will undertake independent teaching and research in his or her discipline or related area. In research and/or scholarship and/or teaching a Level B academic will make an independent contribution through professional practice and expertise, and coordinate and/or lead the activities of other staff, as appropriate to the discipline.

A Level B academic will normally contribute to teaching at undergraduate, honours and postgraduate level, engage in independent scholarship and/or research and/or professional activities appropriate to his or her profession or discipline. He or she will normally undertake administration primarily relating to his or her activities at the institution and may be required to perform the full academic responsibilities of and related administration for the coordination of an award program of the institution.

The standards are not exhaustive of all tasks in academic employment, which is by its nature multi-skilled and involves an overlap of duties between levels.
