

## **STATUTE 5.2-ENTRY QUOTAS, ADMISSIONS AND ENROLMENT**

1. In this Statute, unless the contrary intention appears-  
"Vice-Chancellor" means the Vice-Chancellor or his or her delegate.
2. The Vice-Chancellor may decide who may in any year-
  - [a] be enrolled as students in the University;
  - [b] be admitted to a particular course in the University.
3. The Vice-Chancellor may, after consultation with Academic Board, specify by Regulation the conditions under which any person may be eligible for admission to any course or to be enrolled for any unit or group of units.
4. The Vice-Chancellor shall specify, in accordance with Regulation 5.2, the terms under which students may be admitted with credit for prior studies or recognition of prior learning.

### **Enrolment**

5. (1) Subject to Statute 9.1-Fees and Charges and Statute 9.2-Fees and Charges (TAFE Division), a person shall enrol by lodging with the Vice-Chancellor the form of enrolment required by the Vice-Chancellor before commencing any course.
- (2) Students admitted to the University under this section shall retain enrolment rights until-
  - (a) the student notifies the Vice-Chancellor in writing of his or her withdrawal from the course;
  - (b) the student's enrolment is terminated under Statute 2.4-The Student Discipline Committee, Statute 5.4- Exclusion for Reasons of Unfitness, Statute 5.5- Unsatisfactory Progress, Statute 9.1-Fees and Charges or Statute 9.2-Fees and Charges (TAFE Division);
  - (c) he or she fails to enrol without first having obtained leave as prescribed.
- (3) The enrolment of a person in any course or unit in the University shall be on the condition that the person shall comply with-
  - (a) the Statutes and Regulations of the University and of the lawful instructions of staff of the University; and
  - (b) any special conditions relating to that enrolment agreed to by the student and the appropriate school or imposed under the Statutes.

6. The Vice-Chancellor may, after consultation with Academic Board, make Regulations relating to deferred enrolment, withdrawal from a course and re-enrolment.

#### **Amendment of enrolment record**

7. The Vice-Chancellor may by Regulation specify the relevant dates and conditions under which a student may notify the Vice-Chancellor of details of any matter relating to the student's enrolment which requires amendment of his or her enrolment record.

#### **Appeals**

8. Academic Board shall establish a committee to hear appeals relating to admission and enrolment.

#### **Regulations**

9. (1) The Council and the Vice-Chancellor may at any time make Regulations, not inconsistent with this Statute, prescribing all matters which by this Statute are required or permitted to be prescribed, or which are necessary or convenient to be prescribed for carrying out or giving effect to this Statute and by later Regulation revoke or amend any such Regulations.  
  
(2) Regulations made under this Statute shall be promulgated by being exhibited on the official notice boards of the University and after being so promulgated shall remain so exhibited for at least fourteen days during which time the University is operating.
