Purpose

This Contract Notification is to advise you that new and updated fact sheets, templates and other guidance information is available in SVTS to help you understand the 2023 VET Funding Contract (the Contract).

We will publish the fact sheets and 'Questions and answers about the VET Funding Contract' on the <u>department's website</u>.

This Contract Notification also notifies you about the prescribed 2023 online service standards.

Background

We published the 2023 contracts (version 2) on SVTS on 19 December 2022.

We publish fact sheets on specific topics to help you better understand your obligations under the contract. We expect you to read them and refer to them as a first step in answering any queries you might have. Lodge an enquiry on SVTS if you need clarification or have further questions.

We have a new fact sheet and two significantly revised guides:

We updated all our existing fact sheets and guidance materials to reflect the 2023 contract changes. We continued to make our products easier to understand by writing in clear and concise language. We also added new design elements, such as icons, tables and flow charts, and restructured some content for greater readability.

In the 2022 training provider survey you told us that sometimes it can be difficult to find the information you need. To help you, we've created a single reference document titled '2023 fact sheets' that combines all our fact sheets and guidance in one place. You can access this in the Documents section of SVTS.

Online service standards Where any training or assessment is delivered online, you must publish your 'online service standards' in a prominent place on your website (Clause 1.3 (e) of Schedule 1). The online service standards help students make an informed choice about what delivery mode and training provider will best suit their training needs. We've provided a sample of a completed online service standards for your reference. This is now easier to read. We made no substantive changes.	2023 online service standards	December 2022
