


The central image is a eucalyptus tree, a hardy, strong, and long living tree of knowledge that is both ancient and modern. Very sacred to many different clans, it has its roots in the creation of Gondola Land, the original land mass. The tree is known for its strength to survive in inclement weather, from being covered in freezing snow to desertification situations. It is strong, which represents our National Centre's resilience.

The tree's many roots go through the subsoil that has several layers that are representative of the territories and states of Australia. The subsoil is ochre which is representative of our First Nations connections and the roots of the tree are cemented into all states and territories. Imaging our national impact by its connection through several layers of substrata which is Australia.

The tree's trunk is reaching up, it's branches then reaching out into the sky. This depicts our National Centre's aims and aspirations which are varied illustrating the different research genres that our staff represent and our mixed and varied backgrounds. But all are linked into a strong trunk, with its roots firmly ground into mother earth.

The upper background is sky blue which is the future and our pursuit into the living world around us, the future, our academic aspirations that are tangible and intangible – beyond the present.

# Message from the Associate Deputy Vice-Chancellor Reconciliation

2024 has been a very busy and impactful year for the National Centre for Reconciliation, Truth, and Justice.

Following the devastating result of the 2023 First Nations Voice to Parliament Referendum, the National Centre for Reconciliation, Truth, and Justice continues to strongly support the Uluru Statement from the Heart and its calls for Voice, Treaty, and Truth.

We work with the First Peoples Assembly of Victoria and the Yoorrook Justice Commission to support their nation-leading work on Treaty and Truth. We sponsored Treaty Day Out in Ballarat and Treaty in the Park in Werribee and have held public seminars on the importance of Treaty and Truth.

We lead national and regional understandings and engagements on reconciliation, truth, and justice. In undertaking this work, we engage with community, academic, and industry, through research, education, outreach, engagement, and advocacy activities.

We have grown our internationally renowned team with the appointment of Professor Emma-Jaye Gavin as Australia's inaugural First Nations Professor in Truth-Telling. She joins existing academics Professors Bindi Bennett, Dennis Foley, and Emma Lee, Jesse Fleay, and myself.

The team has received much recognition for their work. Professor Bennett was elected to the Board of Directors of the Australian Association of Social Workers. Jesse Fleay was invited to co-host Global Citizen on Narrm with other international leaders, musicians, and artists. Professor Foley was formally recognised at ANU as a senior leader in his field of research. Professor Gavin was invited to speak to the national Voice, Governance and Institutional Integrity Community of Practice. Professor Lee chaired a session at ASEAN as a first Indigenous Australian in expanding reach of Indigenous inclusion. I was invited to speak at numerous events around Australia about reconciliation in a post-Referendum environment.

After establishing our Annual Reconciliation Lecture in 2023, we organised and hosted the 2024 lecture on 14 October. Held on the one-year anniversary of the Referendum, it featured an engaging conversation with eminent First Nations leaders, Dr Jackie Huggins AM FAHA, Commissioner Sue-Anne Hunter, and Rueben Berg, moderated by myself, on Reconciliation, Voice, Treaty, and Truth.

In 2024, we created the inaugural National Centre for Reconciliation, Truth, and Justice Public Lecture Series. We held three lectures during the year – Professor Dennis Foley spoke on Indigenous business at Ballarat in March; Jesse Fleay spoke on constitutional reform at Berwick in June; and Professor Emma Lee spoke about cultural engagements at Morwell in September.

In December, we co-hosted two conferences, "Class, Race, Place: Exploring Intersectionality for Access to Higher Education Globally", with the Alliance of Working-Class Academics, and "Barriers to Truth-Telling", with the Australia Centre at the University of Melbourne. Both conferences were co-convened by Professor Gavin.

Throughout 2024, we have again been highly successful in obtaining research funding from many sources, including ARC, philanthropic, and government, with our current grants totalling over \$13 million. Details of our grants, along with our publications, and other key outcomes, are listed in the Appendix.

In December, Jesse Fleay was appointed to Research Fellow from 2025, following an outstanding year as Research Associate at the National Centre. We also welcomed Alex Radoll for a six-month appointment as Project and Administrative Officer while Sara Jubran is on parental leave.

I would like to gratefully acknowledge and thank the wonderful efforts from our whole National Centre team – staff, Advisory Board members, adjuncts, and partners – that has enabled us to have had such an impactful and outstanding year. I am very honoured to be part of this extraordinary team.

We very much look forward to another successful and enjoyable year in 2025.

#### 2024 Annual Reconciliation Lecture

On October 14, 2024, to mark the one-year anniversary of the First Nations Voice to Parliament Referendum, the National Centre for Reconciliation, Truth, and Justice held our second Annual Reconciliation Lecture at Melbourne Museum.

The lecture, "One Year on from the Referendum – Where are we with Reconciliation, Voice, Treaty, and Truth?" featured a panel of eminent First Nations speakers that discussed a range of issues regarding Reconciliation, Voice, Treaty, and Truth.

The panellists were Dr Jackie Huggins AM FAHA, First Nations leader in reconciliation for over 40 years, Commissioner Sue-Anne Hunter, Deputy Chair Yoorrook Justice Commission, and Rueben Berg, Co-Chair First Peoples Assembly of Victoria. The panel was moderated by Professor Andrew Gunstone.

The sold-out audience was privileged to hear the panel discuss many issues, including the Referendum and its impact over the past year, where the nation is today with reconciliation and the need for substantive reconciliation, the importance of Truth-telling and Treaty, the nation-leading and transformational work of the First Peoples Assembly of Victoria and the Yoorrook Justice Commission, the links between reconciliation, Voice, Treaty, and Truth, and how allies can engage.

Other highlights of the lecture included a wonderful Welcome to Country from Wurundjeri man Colin Hunter Jnr Jnr, the presentation of beautiful gifts from Wathaurong Glass to our panellists, the information stalls from the National Centre, Reconciliation Victoria, and the First Peoples Assembly of Victoria, and the special opening of the amazing Bunjilaka Aboriginal Cultural Centre for the lecture attendees.

# Awarding of an Honorary Doctorate to Dr Jackie Huggins AM FAHA

One of the highlights of the year was the awarding of an Honorary Doctorate to Dr Jackie Huggins AM FAHA from Federation University at a graduation ceremony in Berwick on 16 October 2024.

Dr Huggins has been a national leader in reconciliation for more than four decades, and has been at the forefront of every major reconciliation milestone during this time, ranging from her work at the Council for Aboriginal Reconciliation, to Co-Chairing Reconciliation Australia, to being a member of last year's Referendum Working Group and Engagement Group.

Dr Huggins has also made an enormous contribution to Federation University, including serving on the National Centre for Reconciliation, Truth, and Justice's Advisory Board, launching the National Centre in early 2023 with Senator Patrick Dodson, speaking at our events supporting a First Nations Voice, and co-delivering our 2024 Reconciliation Lecture.

# Roads to Reconciliation: Activating Multicultural Communities

One of the National Centre's most transformational projects across 2023 and 2024 was the Roads to Reconciliation: Activating Multicultural Communities project. This was funded by the Victorian Government and partnered with Reconciliation Victoria and regional ethnic councils. It was led by National Centre Adjunct Senior Research Fellows, and former Victorian Multicultural Commissioners, Maria Dimopoulos AM and Shankar Kasynathan, and supported by other National Centre staff, Professor Andrew Gunstone, Jesse Fleay, and Sara Jubran.

Throughout the project, it provided an opportunity to:

- build civic literacy in relation to power and tiers of government, as many newly arrived communities don't understand the difference as it concerns their own potential advocacy efforts;
- build the capacity of multicultural community leaders to become actively involved in the pursuit of truth, reconciliation, and justice for First Nations peoples, in the form of fellowships; and
- increase the understandings in multicultural communities of Indigenous led advocacy efforts, and the key issues of reconciliation, truth, and justice.

The project made a significant impact on Victoria's multicultural communities, bringing together First Nations leaders like Uncle Charles Pakana, Commissioner Sue-Anne Hunter, and Ngarra Murray, reconciliation advocates, and multicultural community members, creating a space for dialogue, learning, and collaboration.

The emerging leaders who participated in the Community Fellows Program are now equipped with the knowledge, skills, and tools needed to advocate effectively for broader reconciliation efforts. They have become informed and empowered advocates, ready to lead their communities in meaningful discussions on reconciliation, truth, and justice.

The project culminated with a community fellow's graduation event at the Koorie Heritage Trust. This event was attended by The Hon Ingrid Stitt, Minister for Multicultural Affairs and members of local governments and regional ethnic councils, and underscored the importance of recognising the achievements of the fellows and the broader project. It provided a platform to celebrate the participants' dedication to reconciliation and multicultural advocacy, while also fostering deeper connections between government, First Nations communities, and multicultural leaders. This event highlighted the project's impact and reaffirmed the collective commitment to advancing reconciliation across Victoria.

This lecture was part of a broader event on the Republic we co-hosted with the National Republic Convention, that featured Mat Thistlethwaite MP, Assistant Minister for the Republic, Professor Emma Lee, Professor Andrew Gunstone, and Professor Jenny Hocking.

# Class, Race, Place: Exploring Intersectionality for Access to Higher Education Globally Conference


Professor Emma-Jaye Gavin and the National Centre for Reconciliation, Truth, and Justice, in partnership with the Alliance of Working-Class Academics, co-hosted the "Class, Race, Place: Exploring Intersectionality for Access to Higher Education Globally" Conference on December 6, 2024. The online conference included two keynote addresses, a series of conference presentations, and a panel discussion.

The first keynote was delivered by Professor Jay Phillips (Monash University) on "Truth-telling for colonial contexts: Intersectionality, silencing, and equitable access". The second keynote was delivered by Gavin Brewis (Scottish Poverty and Inequality Research Unit, Glasgow Caledonian University) on "Intersections of class, identity, and institutional power within Scottish education system".

The conference presentations were delivered by academics and research students from across Australia, Aotearoa NZ, England, and Scotland, and contained intersectional themes, such as class, race, sexuality, gender, migration/asylum, and location.

The panel discussion, which was moderated by Professor Gavin and Professor Steven Roberts (Monash University), featured key leadership members from the global Alliance of Working-Class Academics, who discussed their mission to "Abolish Global Class Discrimination".

Papers from the conference will be published in a special issue of the Journal of Australian Indigenous Issues.





# In Conversation with Thomas Mayo

In August, the National Centre for Reconciliation, Truth, and Justice held a special event in Ballarat. "In Conversation with Thomas Mayo" was a panel discussion with Thomas Mayo, Sheree Lowe, and Professor Andrew Gunstone, moderated by Deb Lowah Clark.
