

For Students:

Name and/or gender details to be changed on selected systems

Federation University aims to be a safe and inclusive place for all staff and students. It is recognised that a student may seek to change their name and/or gender to feel safe and included.

This form is intended to be used in instances where a student needs to be identified in University systems as a name and/or gender that is different from the name and/or gender shown on their legal identification such as birth certificate or passport.

Some of the reasons a students may wish to change their name and/or gender details may include gender affirmation, for safety reasons relating to family violence, or to align with a student's identity.

Process

- 1. Fill out the form on page 2. Student Equity & Inclusion can assist if needed.
- 2. Sign the form and send to equity@federation.edu.au
- 3. Student Equity and inclusion will contact you to discuss the process, timelines and any other supports you may require. You will be able to safely and privately confirm the need or reason for name and/or gender details change. The reason/s will NOT be noted on the form or shared further without your consent.
- 4. Student Equity and Inclusion will manage the process of changes on University systems and liaise with you on progress.

System limitations

Systems that cannot be updated to the changed name due to legislative requirements:

- Student record (Academic Transcript and Enrolment Confirmation)
- InPlace the placement platform for workplace experience (employers require legal name)
- · Finance system (invoices need to be in the legal name of the party)

As name/gender changes cannot be made in some systems, there may be circumstances where the legal identity of the student will be apparent. While the University will take steps to avoid the disclosure of the student legal identity, it cannot be guaranteed. Student Equity and Inclusion will discuss these limitations with you.

Where safety reasons are identified as the reason for name change, Student Equity & Inclusion may offer information about additional supports offered by the University or externally.
