#### Guidelines:

Students are invited to submit an original photo to [equity@federation.edu.au](mailto:equity@federation.edu.au) focusing on the theme “How are you supporting IDAHOBIT 2025?” The photo may include a self-portrait, engagement in an IDAHOBIT activity, your own artwork, original digital image, or even a written reflection based on the theme.

Entrants are required to ensure that all persons who may appear in the entry photograph have provided explicit consent to these terms and conditions including the section on ‘Consent’ below. This may include the image appearing on Federation University social media.

Information on prizes and how to enter form part of these Terms and Conditions of Entry (“the Conditions”).

By entering this Promotion, all Entrants will be deemed to have accepted and agreed to be bound by these terms and conditions.

The Terms and Conditions of this Promotion are governed by the laws of the State of Victoria.

Entry to the Promotion is open to all current Federation University students at the time of entry into the Promotion. Employees and immediate family members of the Promoter and/or any agencies associated with this Promotion are ineligible for entry]. [Entrants under 18 years of age must have parental and/or guardian approval to enter and it is the Entrant’s responsibility to ensure that the parent and/or guardian of the Entrant has read and consented to these Terms and Conditions].

[Only one (1) entry per Entrant is permitted. Any subsequent entry after the first valid entry is received will be deemed invalid]. Entries are deemed to be received at the time of receipt [by the date received on Federation University Australia [equity@federation.edu.au](mailto:equity@federation.edu.au) and NOT at the time of transmission by the Entrant.

The judging will be conducted by a professional panel at Federation University's Mt Helen Campus between 9.00am -12.00pm AEST on Monday 19 May 2025. The winning entrant and the 'winning entries' will be the ones drawn randomly first and in succession', by the judges (3 in total) at Federation University's Student Equity and Inclusion Office. The winning Entrant/s will be notified within 2-3 business days of the competition closing date. Winning Entrant/s will be announced on the official Federation University Australia "Feduni Current Student" Meta page/s and/or Student Newsletter/specific webpage within 5 business days. The Judges' decision is final and no correspondence will be entered into.

To enter, Entrant's must take the photograph and submit to [equity@federation.edu.au](mailto:equity@federation.edu.au) within the competition timelines.

The first complete entry randomly selected will receive a \$100 PREZZEE voucher. An additional 2 entries drawn will receive a PREZZEE voucher to the value of \$100 each.

Total prize pool value is up to AUD \$300 RRP incl. GST. The Promoter accepts no responsibility for any variation in the prize value. Prizes, or any unused portion of a prize, are non-transferable or exchangeable and cannot be taken as cash. In the event that a prize, or an element of a prize, is/are not available, the Promoter reserves the right to substitute prize(s) in its discretion to the same and equal recommended retail value and/or specification subject to any written directions from the various lottery Departments.
